



The Articles of Incorporation of ANESTHESIOLOGISTS PROFESSIONAL ASSURANCE COMPANY, a Florida Corporation ("The Corporation"), which were originally filed with the Florida Insurance Commissioner and Treasurer now known as the Chief Financial Officer of the State of Florida on July 2, 1991 and with the Florida Secretary of State on July 23, 1991 (the Articles"), and which were thereafter amended by the filing of the Articles of Amendment to the Articles of Incorporation of Anesthesiologists Professional Assurance Company with the Florida Secretary of State on June 30, 1998 ("the First Amendment to the Articles"), and which was thereafter amended by the filing of the Articles of Amendment to the Articles of Incorporation of Anesthesiologists Professional Assurance Company with the Florida Secretary of State on January 4, 2001 ("the Second Amendment to the Articles") be and hereby are amended in the following manner:

1. Article I is hereby deleted in its entirety from the Articles, the First Amendment, and the Second amendment to the Articles and the following is hereby inserted in its place:

ARTICLE I

The name of the corporation shall be ANESTHESIOLOGISTS PROFESSIONAL ASSURANCE COMPANY. The principal place of business of this corporation shall be 1000 Riverside Avenue, Suite 800, Jacksonville, Florida 32204.


