ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF McGUIRE, PRATT, MASIO & FARRANCE, P.A.

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporatio filed May 9, 1994, under Charter No. S69652.

1. The name of the corporation is amended:

2. The Articles of Incorporation are amended by adding the following Article:

ARTICLE V-1

The Corporation is authorized to issue up to 500 SHARES of Class B stock. Said stock shall have a value of \$1.00, and shall not be entitled to any dividend unless expressly authorized by the shareholders of the corporation. The Corporation may redeem any issued stock at any time without any penalty or premium. The stock shall not be entitled to any rights to vote on matters brought before the Shareholders, except as required by Florida Law.
