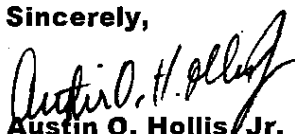
I would like to contest the administrative dissolution of my corporation for the following reasons as outlined in the Reinstatement Application:

No notices of any sort regarding this corporation were received at either the current Registered Agent or the only office of the corporation at 2974 Hartley Road, Jacksonville-32257. The corporate Finance Manager, which I am appointing as the new Registered Agent, had only received the acknowledgment of Corporate Name Change in Letter #003A00026398 dated April 30th prior to the receipt of the Dissolution Notice on October 10, 2003.

There was some confusion at the office as a payment had been authorized on my personal MBNA credit card account for \$150 to the Florida Department of State on 3/31/2003. It was assumed at that time that it was the annual filing fee for this corporation. My Finance Manager started working for the corporation on March 17th of this year and he erroneously determined that the annual UBR filing had already been completed based on the information available to him.

I strongly believe that the name change process at the normal renewal time for corporations probably fouled up the mailing procedure. It was easy to assume that if you create a new corporation, even in name only, that it is tantamount to filing the annual report. I believe that having the Registered Agent at our office will solve any confusion in the future.
