A special meeting of the shareholders of Blue Marlin Breweries, Inc. was held on May 20, 1997 and on said date a majority of shareholders holding shares of common stock, with voting rights (there are no other voting groups entitled to vote), of the corporation unanimously adopted the following amendment to the Articles of Incorporation.

*ARTICLE III. STOCK
