**ARTICLES OF AMENDMENT OF THE
ARTICLES OF INCORPORATION**

Pursuant to the provisions of FSA § 607.1006, this corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is **DEPENDABLE PROTECTIVE MUTUAL RISK RETENTION GROUP, INC.**

2. The text of each amendment as adopted is as follows:

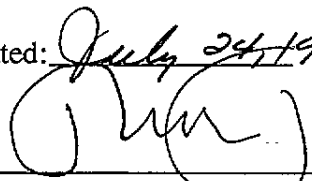
Article Sixth--Directors is deleted in its entirety and replaced as follows:
