The undersigned, acting as the Directors of the above named corporation created under the Florida Business Corporation Act, hereby adopts the following Articles of Amendment for such corporation pursuant to Section 607.1403, Florida Statutes.

ARTICLE I

The name of the corporation is changed to Melinda Leeson, P.A.

ARTICLE II

The corporation shall be governed and subject to Chapter 621, et. seq. of the Florida Business Corporation Act, and shall hence forth be considered to be a personal services corporation as that term is defined by Chapter 621, for the purpose of conducting business in the discipline of acupuncture therapy to the general public.

ARTICLE III

The Amendments referenced above were adopted on February 15, 2001.

ARTICLE IV
