As the accountant of record for Casablanca Textiles, Inc., I would like to explain the circumstances related to the late filing of this report.


The taxpayer sent me the Uniform Business Report booklet to prepare for their signing in early February 2000. Unfortunately, a serious medical situation was discovered, testicular cancer, and radical surgery was performed on me on February 28, 2000 followed by radiation treatments, which ended in May 2000. Prior to my surgery, I intended to prepare all of the Uniform Business Reports for my clients, but, somehow, this particular one slipped through the cracks and was discovered unprepared in my client file. Immediately, the taxpayer was informed of my oversight and was sent the form to execute with payment. The taxpayer's medical condition is the sole reason for the late filing of this report.

On August 28, 2000, I spoke to Megan in Public Inquiry of these circumstances. Megan explained that the reason for late filing meets the department standard for reasonable cause and that the penalty for late filing should not be applied.

It is respectfully requested that the penalty for late filing and payment not be assessed due to reasonable cause. Your consideration is greatly appreciated.
