**FIRST:** Amendment adopted: Article I, as previously amended by Articles of Amendment filed as of April 7, 1992, is deleted and in lieu thereof the following is inserted:

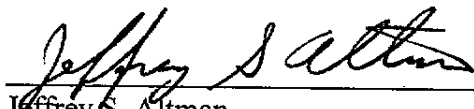
The name of the Corporation shall be TPC Communications, Inc.
