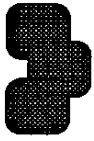


We were surprised that we had not received any corporate form to date, even though other mail has been forwarded from the old address on Amberly.
