My situation is as follows: I am the only officer still "active" in the corporation, and I have been residing abroad, in Central America, for all of 1998; because the local mail is so slow and unreliable, I only received the "second notice" yesterday (and never did get the "first notice"). Moreover, the corporation, which has no employees, has been producing much less revenue than in the past as its business winds down, a trend which has been especially pronounced this calendar year.

For the foregoing reasons, I respectfully request that the \$400 late filing fee be waived for Ganahl Software, Inc.
