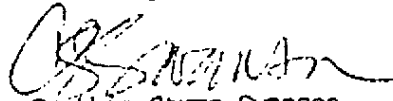

The power to adopt, alter, amend or repeal Bylaws shall be vested in the shareholders of this Corporation.

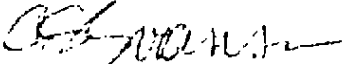
ARTICLE X - Indemnification

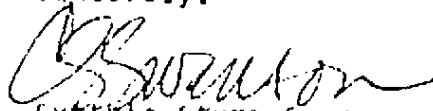

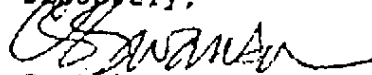
