Pursuant to the provisions of Section 607.1006 of the Florida Statutes, ONSIGHT, INC., a Florida for profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The current name of the Corporation is OnSight, Inc.
2. The original Articles of Incorporation for the Corporation were filed on September 4, 1991, and assigned Document Number S78193.
3. On December 31, 2018, the sole shareholder of the Corporation voted to (i) change the name of the Corporation, (ii) remove an officer and director of the Corporation; and (iii) adopt and file Articles of Amendment.
4. The name of the Corporation is amended to GREYFIELD HOLDINGS INC.
