ARTICLES OF AMENDMENT
OF

(Formerly Florida Scientific Laboratories, Inc.)

Pursuant to the provisions of Section 607.1003(6) of the Florida Statutes, the undersigned corporation, originally incorporated under the name Alachua Scientific Laboratories, Inc. on September 9, 1991, which corporation subsequently changed its name to Florida Scientific Laboratories, Inc. on April 20, 1992, and pursuant to a resolution duly adopted by its sole shareholder on June 17, 1999, hereby adopts the following amendment to its Articles of Incorporation:

1. Article I is amended in its entirety to read as follows:


The shareholder waives notice of the meeting, and enacts the following Resolution:
