Pursuant to a recent telephone conversation with Michelle in your office, we are requesting waiver of the \$ 600 Reinstatement Fee. Our Company, Mullins-South, Inc. (Florida document number S79922, FEI number 593090487) had been administratively dissolved for failure to file annual reports.

The Company has also been involved in the Chapter 7 bankruptcy case of Mr. John Robert Mullins (Case Number 98-50517 in the Western District of North Carolina). On March 6, 2002, the Honorable J. Craig Whitley, United States Bankruptcy Judge, issued an order granting the Chapter 7 bankruptcy trustee, Mr. Barrett L. Crawford, ownership and control of Mullins-South, Inc.
