ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF DANIA-AUGER, INC.

Pursuant to the provisions of Section 607.1006, Florida, Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The Articles of Incorporation are hereby amended as follows:

ARTICLE IV CAPITAL STOCK

This Corporation is authorized to issue one thousand(1,000) shares of voting Common Stock having a par value of \$1.00 and one thousand (1,000) shares of non-voting Common Stock having a par value of \$1.00. Both classes of stock shall be equal in all aspects with the exception of voting rights. Each class of stock shall be considered equal as to liquidating dividends. The consideration received for issuance of said stock shall be as determined by the Board of Directors. After payment to the Corporation by cash, services actually performed, or tangible property for said shares, such shares shall be deemed to be fully paid and non-assessable.
