Dear sir or madam:

My accountant and I have spoken with a Mr. Andy Dunlap and several other individuals in your office regarding the reinstatement of my corporation. Per their instructions I have enclosed check number 1916 from the Chelsea Consulting Group in the amount of \$ 300.00 to pay for the following:

2004 and 2005 Annual Report fees:	\$ 61.25,	\$ 122.50,
Corporate Supplemental Fees:	\$ 88.75,	\$ 177.50.

They all stated that I should request a waiver of the reinstatement fee(s) based on several factors that precluded me from responding to your renewal notice:

- 1) I had a home-based business at 1710 Tiger Tail Avenue, Miami, Florida, 33133.
- 2) My wife separated from me in June of 2002. She stayed in the house, I took an apartment. All mail was still directed to the 1710 Tiger Tail house.
- 3) I was hospitalized with a stroke and a seizure for approximately three (3) weeks in July, 2002.
- 4) In early July, 2002, I rented an apartment on Day Avenue in Coconut Grove. All mail was still directed to the original address: 1710 Tiger Tail Avenue.
- 5) Very little of my mail was forwarded to me at Day Avenue. Most of my mail, both personal and corporate, was withheld (confiscated) by my wife (now ex-wife) and given to her attorney and/or her accountant. These mailings: credit cards, family mail, and most

importantly for the purpose of corporate refiling notices, were withheld and only returned to me --- piece-meal --- in late 2004 and 2005.

6) There were, in fact, two reasons that I was "out of the loop". The first was that my ex-wife purchased a home at 2497 Abaco Avenue in Coconut Grove in July of 2003. As a consequence, the mail originally directed to 1710 Tiger Tail Avenue, was now re-directed to my ex-wife's new Abaco Avenue Address, and was never passed on to me at Day Avenue in Coconut Grove: the mail was either withheld or redirected --- but not to me.

The second reason was, as I noted, my stroke and my seizure. I am, essentially, recovered from my stroke but not my seizure. I, in fact, require assistance to be "on top" of day-to-day details, and to check my typing. Unfortunately, this means that items that I was once aware of, such as corporate filing, etc., I am unfortunately no longer aware of unless I get constant reminders.

7) I purchased my home, and moved my business, to 3158 Florida Avenue in August of 2003. Unfortunately, most of my personal, business, corporate, and tax correspondence continued to be addressed to my former wife's address at 2497 Abaco Avenue. It was only relatively recently that business correspondence actually began to arrive at my current address: 3158 Florida Avenue.

I, frankly, am not sure if the materials in question (and previous items) were "destroyed", "side-lined", or merely "mis-directed" by certain parties mentioned above. All I know, ladies and gentlemen, is that I was unaware of these documents and, thus, was unable to respond to them. My apologies.

As you can see from my records going back over a decade, I have always been scrupulous in filing and paying --- and doing both early.

8) I have enclosed copies of three documents that you have sent me relatively recently. All three of these were addressed to 2497 Abaco Avenue, Miami, my former wife's address, not the address of record when the CHELSEA CONSULTING GROUP was incorporated in Florida at 1710 Tigertail Avenue, Miami, nor my current address at 3158 Florida Avenue, Miami.

As I noted, I did not get any of these documents as they were not forwarded to me until comparatively recently. Secondly, given my relatively recent incapacitation, I would have been "on top of this" but
