Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

- FIRST:** The name of the corporation is Express Quote Services, Inc.
- SECOND:** The Articles of Incorporation of Express Quote Services, Inc. have been amended by adding the following purpose clause:
- SEVENTH: The purpose or purposes for which the corporation is organized:
- The transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.
- THIRD:** The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
- FOURTH:** The amendment was duly adopted on July 17, 2000 by the Board of Directors without shareholder action and shareholder action was not required.
