**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
EXPRESS QUOTE SERVICES, INC.**

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

- FIRST:** The name of the corporation is Express Quote Services, Inc.
- SECOND:** The Articles of Incorporation of Express Quote Services, Inc. have been amended by changing the Third Article in its entirety and by substituting therefor the following:
- “The number of shares the corporation is authorized to issue is: five hundred (500) Common Shares, Two Dollar (\$2.00) par value.”
- THIRD:** The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
- FOURTH:** The amendment was duly adopted on November 7, 2000 by the Board of Directors without shareholder action and shareholder action was not required.
