
Enclosed please find our application for reinstatement. Also, after discussing our circumstances with one of your examiners, the following was requested as an explanation of the particular reasons why this lack of renewal occurred.

Our last renewal was for 2001 from our address at 17211 123rd Terrace North, Jupiter, FL 33478. Subsequent to that, in 2001, our corporate address was moved to **10034** Trailwood Circle, Jupiter, FL 33478. This address was valid for less than one year. Early in 2002, we moved to our permanent address at **10371** Trailwood Circle, Jupiter, FL 33478. Prior to our present current address, the accounting firm that represents us, Keefe, McCullough & Co., was instructed to handle all matters of renewal for us. As it turned out, due to the confusion of our move and the lack of action by our accounting firm, our corporation was not renewed.
