**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF

Pursuant to the Florida Business Corporation Act, **YOUNG PEST CONTROL NORTHWEST FLORIDA, INC.**, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article I of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety as follows:

ARTICLE I

Corporate Name and Principal Office


