## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FIBERTEL, INC. FILED SECRETARY JUL -1 PM 1: 29 ARTICLES OF INCORPORATION TALLAHASSEE, FLORIDA

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is **FIBERTEL**, **INC**. (the "Corporation"), Charter #S87031, filed on October 14, 1991.
- 2. The following Amendment to the Articles of Incorporation was adopted by all of the Directors of the Corporation and all of the Shareholders of the Corporation, the number of votes cast being sufficient for approval, on January 12, 1995 in the manner prescribed by Section 607.1003 of the Act:

## ARTICLE III

This Corporation shall have the authority to issue One Hundred Thousand (100,000) shares of Common Stock, having a par value of \$.001 per share.

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
