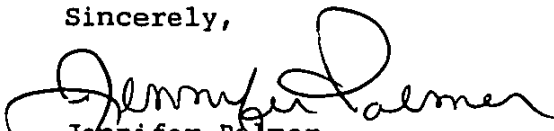
Dear Amy:

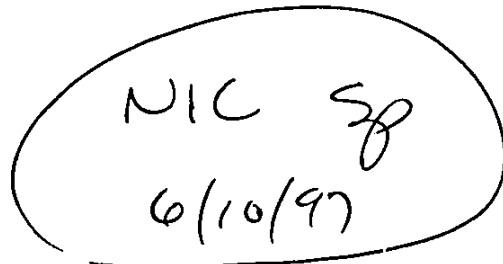

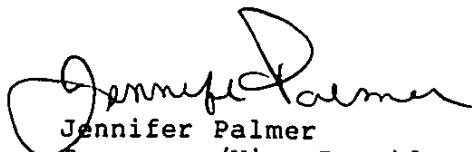
