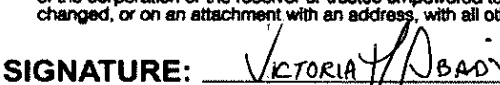

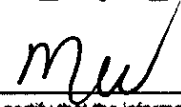

This letter is to ask the Department Of State to forgive me for mailing this report with the payment so late.

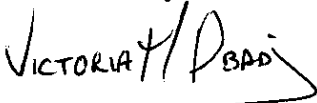
I didn't received the report by mail, maybe because we had moved to a new location. And, you know, some times the mail doesn't get forward to the new place.
