I have just found out that the above referenced corporation is in an inactive status due the non-payment of the fee for the Profit Annual Report. We found this out because we are switching banks and a bank account executive called and informed us about the current status.

This non- payment came about because of our address change back in 1999 and since the year 2000 we have not paid the Profit Annual Report fee. We thought that the accountant was requesting and paying for this, and at the same time he thought we were doing this on our own.

To the best of my knowledge we are current in every other taxes that are due, at every level, county, state and federal. We are not liable for municipal taxes because we moved from the City of Miami into unincorporated Miami Dade County back in 1999 and that was the cause for this mishap.

I therefore kindly plea that the reinstatement fee for A.L.S.S. Inc. be waived in this instance.

As per telephone conversation with an agent at the Florida Department of State, I was told that it would be possible to pay the respective Profit Annual Report fee for the years of 2000, 2001, 2002, 2003, and 2004 and that such amount is \$750.00. Enclosed please find our check nr.4903 in the amount of \$758.75 made out to the Florida Department of State Please for payment of the Profit Annual Report fees for the years of 2000, 2001, 2002, 2003, 2004 and a properly filled and signed application. The additional amount of \$8.75 included in the check is for the issuance of a Certificate of Status to be mailed to us.
