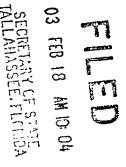

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE TOTAL QUALITY GROUP, INC. (a Florida Corporation)

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, The Total Qualify Group, Inc., a Florida corporation (the "Corporation"), adopts the following articles of amendment to its Articles of Incorporation.

- 1. Name. The name of the Corporation is The Total Quality Group, Inc.
