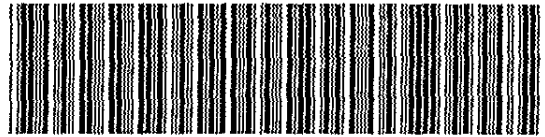



The name of the corporation is: **HEARTLAND HEALTH CARE SERVICES, INC.**


The shareholder of the company approved the dissolution of the company on November 21, 2002.
