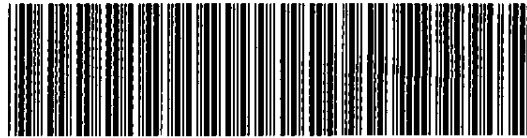




"Article I. Corporate Name. The name of this Corporation shall be:
