2. The dissolution of the Corporation was authorized on June 15, 1998.

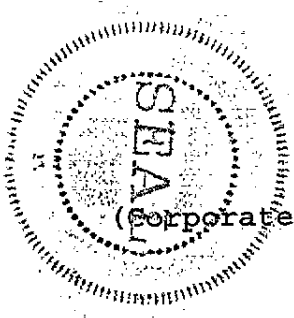
3. The dissolution was approved by the sole shareholder of the Corporation and that vote was sufficient for approval.
