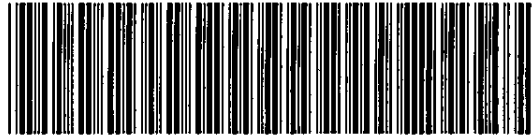

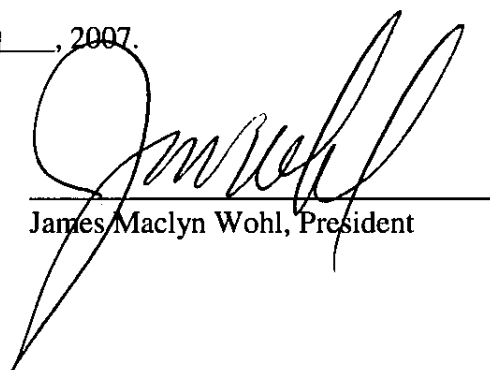

The name of this corporation is: JJW, INC."

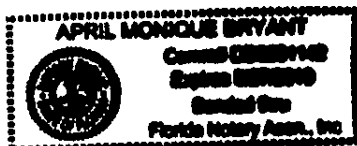

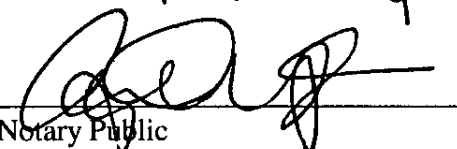
