My Uniform Business Report was not paid on time due to unexpected and unforeseen circumstances. WJT Corp. was formed by my late husband, Joel S. Salzman. When he passed away in 1997 I took over the running of his business. I am the only employee of WJT Corp. and when I am disabled or otherwise unavailable nothing gets done. I had back surgery in April of 2002. In July, I was well enough to attend a family wedding in Boston. I was scheduled to be there four days but the day before I was to return home to Miami, I developed blood clots (Phlebitis) in my legs and did not return home until Sept. 19th. I was in and out of the hospital in Boston for nine weeks. I live alone and requested that my mail be held for me at the Post Office. My only child, my grown son, was not able to get my mail or pay any of my bills. I just got caught up with my Sales Tax and when my son spoke to somebody in your department, he was advised that I should pay the original \$150 and provide a letter of explanation detailing why I was delinquent.

I have made changes that I think will keep this from happening again. My Son agrees that at 67 years of age, I need a little help in the office and he has agreed to have access to the bills so I can keep current in the future.
