On Monday, February 9, 1998, I applied for a tax number at The Department of Revenue in Titusville, Florida. At that time they told me that my corporation status had lapsed. I have been incorporated since November 22, 1991, and have always paid my dues in a timely fashion each year.

I must not have received a '97 filing request from the state.
