Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, this Florida profit corporation submits the following articles of dissolution:

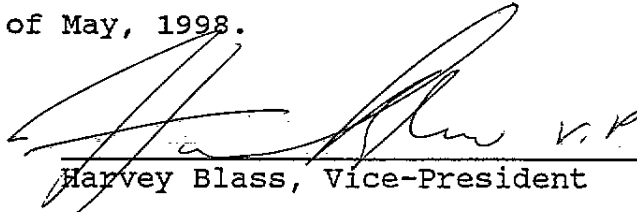
FIRST: The name of the corporation is Liztex International, Inc.

THIRD: Adoption of Dissolution:

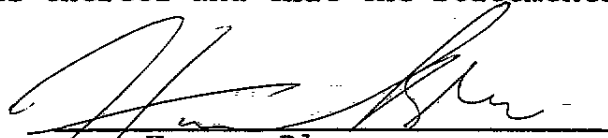
Dissolution was approved by the unanimous consent of the sole shareholder and all of the directors of the corporation at a special joint meeting held for such purpose.

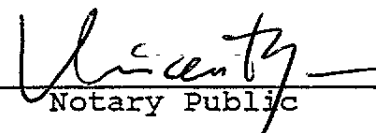
