Higginbotham Finance, Inc.

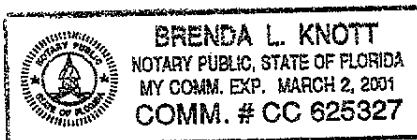
The foregoing amendment was adopted by the shareholders of the corporation as of 9/16, 1998. The number of votes cast for this amendment was sufficient for approval.
