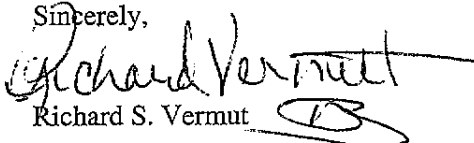
Dear Ms. Harvey:

This letter is in response to the August 28, 2000 communication from your office identified by Letter Number 200A00045908. In that letter the above-referenced service mark application was refused registration for three reasons. During our conversation today, we discussed these three issues and resolved them as follows:

1. The dates of use in Florida and anywhere are set forth in the application as October 31, 1994;
2. The term "HOUSING" has been disclaimed; and,
3. The specimens originally submitted with the application are acceptable. Specifically, the specimen identified as "MEETING NOTICE THE HOUSING ROUNDTABLE" DATED November 18, 1999 satisfied the requirements for registration.
