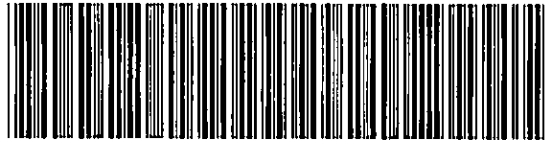


South Broward Hospital District is a special tax district under the laws of the State of Florida. Under Florida Statute 1.01(8), the Hospital District is a political subdivision of the State of Florida. That subsection reads: "The words "public body," "body politic," or "political subdivision" include counties, cities, towns, villages, special tax school districts, special road and bridge districts, bridge districts, and all other districts in this state."

The South Broward Hospital District was created by special act of the Florida legislatures. The powers and duties of South Broward Hospital District are derived from the general laws of the state of Florida and from Chapter 24415, Laws of Florida, Special Acts of 1947, as amended and as re-codified by Chapter 2004-397, Laws of Florida (2004), as amended by Chapter 2016-258, Laws of Florida (2016) (the "Act") which represents the "Charter" of the Hospital District.

As a State Political Subdivision, the Hospital District is not a corporation and is not listed under the Department of State, Division of Corporations. Rather, it is listed by the State of Florida Department of Economic Opportunity, Division of Community Development, found at <https://dca.deo.myflorida.com/fhcd/sdip/OfficialListdeo/alldistricts.cfm>.

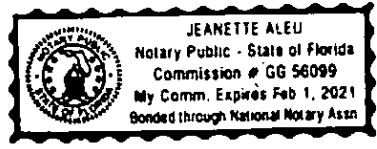

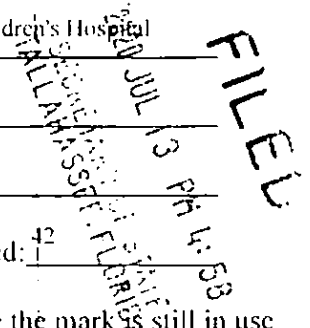
