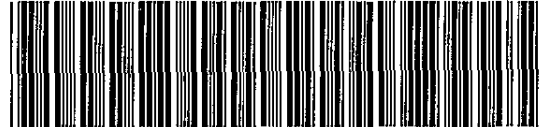

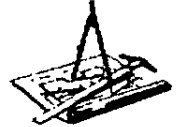

## TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, STAVROS PIZZA HOUSE, located at 262 South Beach Street, Daytona Beach FL 32114 \_\_\_\_\_ (“ASSIGNOR”) and Mary Ioannidis, an individual whose mailing address is 262 South Beach Street, Daytona Beach FL 32114, (“IOANNIDIS”) and The Original Stavro’s Pizza House, Inc., a corporation organized and existing under the laws of Florida, FL Reg. No. V33430, located at 262 South Beach Street, Daytona Beach FL 32114 (“STAVROS”) (collectively “ASSIGNEES”) desire to enter into this agreement (“AGREEMENT”) under whose terms ASSIGNOR wishes to assign STAVROS PIZZA HOUSE “WE DON’T SAY WE ARE THE BEST, OUR CUSTOMERS DO Florida Trademark Reg. No. T00891 (“MARK”) to ASSIGNEE, together with all goodwill of the business in which MARK is used, and

WHEREAS, ASSIGNEES wish to buy MARK together with all goodwill of the business in which MARK is used;

NOW THEREFORE, in consideration of the promises and agreements set forth herein, the parties, each intending to be legally bound hereby, do promise and agree as follows:

1. **CONSIDERATION.** IOANNIDIS hereby pays ASSIGNOR consideration in the sum of \$ 50.00, receipt of which ASSIGNOR hereby acknowledges, in consideration for which ASSIGNOR hereby assigns 51% of all ASSIGNOR’s right, title and interest in MARK to IOANNIDIS. STAVROS hereby pays ASSIGNOR consideration in the sum of \$ 50.00, receipt of which ASSIGNOR hereby acknowledges, in consideration for which ASSIGNOR hereby assigns 49% of all ASSIGNOR’s right, title and interest in MARK to STAVROS. ASSIGNOR retains no interest whatsoever in MARK.

2. **ASSIGNMENT.** ASSIGNOR hereby assigns all ASSIGNOR’s right, title and interest in MARK to ASSIGNEES in the proportions specified in paragraph 1, in consideration of the amount specified in paragraph 1, and ASSIGNOR retains no interest whatsoever in MARK. In addition, ASSIGNOR transfers to ASSIGNEES all goodwill of the business in which MARK is used, in the proportions specified in paragraph 1.

3. **GOODWILL.** As evidence that all goodwill of the business in which MARK is used is hereby transferred to ASSIGNEE, ASSIGNEES will use MARK on product(s) having substantially the same characteristics as the product(s) upon which ASSIGNOR used MARK, and ASSIGNOR will no longer sell under any name the same or similar product(s) upon which ASSIGNOR used MARK, in order to avoid consumer confusion.

4. **CHANGES TO THIS AGREEMENT.** ASSIGNEES and ASSIGNOR agree that all changes to this AGREEMENT must be in writing and signed by both parties.

5. **GOVERNING LAW.** ASSIGNEES and ASSIGNOR agree that this AGREEMENT will be construed and interpreted in accordance with the law of the state of Florida.
