

**AMENDMENT AND CONFIRMATORY ASSIGNMENT**

WHEREAS, by an Assignment effective March 25, 2005 (hereinafter "Assignment"), Safeguard Self Storage, Inc., a Louisiana corporation (hereinafter "Assignor"), sold, assigned, and transferred to Safeguard Operations LLC, a Louisiana limited liability company (hereinafter "Assignee"), the entire right, title, and interest in and to the Service Marks listed on Exhibit A (collectively, the "Service Marks"), such Service Marks having registered in the State of Florida on September 12, 2001; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee acknowledge and confirm that Assignor has as of September 12, 2001 assigned, conveyed, and transferred unto Assignee the entire right, title, and interest in and to the Intellectual Property and the goodwill of the business symbolized by the Intellectual Property, all registrations thereof, and all common law rights therein, including the right to sue for and recover damages and profits, and the right to any other remedies in respect of any infringement of the Intellectual Property which may have occurred before the date of this Amendment and Confirmatory Assignment. This Amendment and Confirmatory Assignment is to have the same legal force and effect as if executed on September 12, 2001.

This Amendment and Confirmatory Assignment is binding upon Assignor and its successors and assigns and shall inure to the benefit of Assignee and its successors and assigns.
