

Existing technologies include STA's – stormwater treatment areas that are essentially huge created wetlands that can reduce the phosphorus load by up to 80 percent. Even so, further reduction is needed to meet the requirement of 10 ppm for inflows to Lake Okeechobee, for example.

Madrid has completed studies that indicate up to 90 percent reduction in total

phosphorus in surface water runoff using a new filtration media, PhosPhilter™. It can be deployed in ditches, pipes, swales, retention ponds and wetlands. The South Florida Water Management District is funding an edge-of-farm demonstration PhosPhilter™, and field test results will be available soon.
