We are in receipt of your letter of August 11, 2004. However, we must disagree with its conclusion denying registration of the above mark on the grounds that it is merely descriptive.

As all the world knows, Florida is a peninsula having hundreds of miles of pristine beaches from Fernandina Beach in the Northeast to Pensacola in the Northwest. Despite these miles of beach, sunny Orlando is situated approximately 30 miles from the east coast of Florida and thus, not particularly near to any beaches.

It is also well known that the people of the northern United States regard all areas of Florida as vacation hotspots with opportunities for sun, surf, golf and other fun outdoor activities year around without regard to beaches. This "buzz" about Florida has created an attitude about Florida such that the mere mention of a location in Florida suggests to the listener that which Florida is famous for, namely, its beaches. This suggestion, which occurs not without some pause to the listener or reader, is what makes ORLANDOBEACHVACATIONS a suggestive, and registerable mark as opposed to a merely descriptive one. See e.g. In re Shutts, 217 U.S.P.Q. 363 (T.T.A.B. 1983) (SNO-RAKE held not merely descriptive of a snow removal hand tool).

Withdrawal of the refusal to register this mark is respectfully requested.
