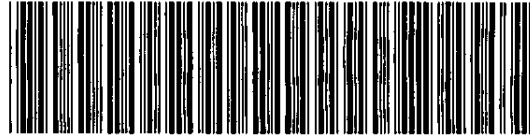



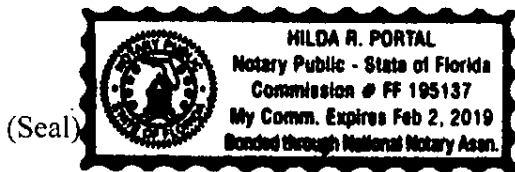

- Echocardiogram — studies blood flow through the valves and evaluates the structure of your heart.

- MUGA scan — produces a moving image of the beating heart and calculates cardiac output, which helps determine the heart's functional capacity.
- Electrocardiogram (EKG) — traces the heart's electrical activity and helps diagnose heart disease, including arrhythmias.

If your family history and other factors place you at a higher risk for heart disease, talk with your doctor about coming to Mariners Hospital for a thorough picture of what's happening to your heart and blood vessels.
