

Responsive to Letter Number 405A00023170 concerning Reference Number W05000017270, dated April 5, 2005, the Applicant submits the following:

REMARKS

Registration of Applicant's mark "A PARTY 4 LESS, INC." for use in connection with the "rental of inflatable rides, rental of cotton, popcorn and snow-cone machines, arrangement for ponies, clowns, and character shows, rental of chairs and tables" has been refused pursuant to \$495.021(f) and \$495.181 of the Florida statutes, on the ground that the mark, when applied to Applicant's goods, is considered to share the same or similar name and class(es) as U.S. Registration No. 2,833,379.

As set forth in the often cited case of <u>In re E.I duPont de</u>

<u>Nemours & Co.</u>, 476 F.2d 1357, 177 USPQ 563 (C.C.P.A. 1973), there

are several points to consider in determining if marks are

confusingly similar. The relevant points for consideration herein

include:

- (1) The similarity or dissimilarity and nature of the goods and services as described in an application or registration;
- (2) The similarity or dissimilarity of established, and likely-to-continue trade channels; and
- (3) The extent to which applicant has a right to exclude others from use of its mark on its goods.

On balance of the above factors, there is no likelihood of confusion, as set forth below.

I. THE DISSIMILARITY OF THE SERVICES.

The mere fact that both marks are used in connection with parties is not dispositive, even when the two marks are similar.

See e.g., Interstate Brands Corp. v. Celestial Seasonings, Inc.,

198 USPQ 151 (C.C.P.A. 1978) (Rejecting a per se rule of likelihood of confusion whenever food items are sold under the same or similar marks, and finding no likelihood of confusion between "RED ZINGERS" for use on herb tea and "ZINGERS" for use on cakes.); In Re Mars,

Inc., 222 USPQ 938 (Fed. Cir. 1984) (finding no likelihood of confusion between the applicant's mark "CANYON" for candy bars and a prior registrant's identical mark for fresh citrus fruit).

One case even rejected a finding that there would be a likelihood of confusion where the food items were related, such as tea and cakes. See Interstate Brands Corp., 198 USPQ 151. However, in this case, it cannot in good faith be argued that the two services are indeed related, nor has such a claim been asserted. Instead, the Applicant's mark has been rejected because the goods are in "a similar class".

As set forth above, this type of cursory analysis has been held insufficient. See In Re Mars, Inc., 222 USPQ 938 (Fed. Cir. 1984) ("mere fact that applicant's and registrant's goods may be sold in the same retail establishment does not by itself establish that the goods are related" - candy bars v. citrus); In re Triton Boat Company, L.P., 220 TTAB LEXIS 232 (TTAB 2002) (same - boats v. scooters); Interstate Brands Corporation, 134 USPQ 37, 39 (TTAB 1962) ("RED ZINGER" for tea and "ZINGERS" for cakes; held no confusion).

As noted, the cited mark is for a "retail store and online ordering services featuring party supplies", while Applicant's mark is for the "rental of inflatable rides, rental of cotton, popcorn and snow-cone machines, arrangement for ponies, clowns, and character shows, rental of chairs and tables". These services are not related, are not used in connection with each other, and do not share similar qualities.

Applicant's services are almost industrial in nature whereby

heavy machinery is rented, live animals are delivered and managed, and live entertainment is planned. Applicant's services are intended for high-end entertaining events that would provide a multitude of services, such as ponies and cotton candy machines. Applicant will not be placing anything for sale. Similar services have previously been listed in International Class 41. See Exhibit 1.

The cited mark, on the other hand, is tailored quite narrowly towards the retail sale of "party supplies". A perusal of their website shows that they provide party supplies such as paper plates, streamers, and party hats. See Exhibit 2. They do not show any use in connection with the "rental of inflatable rides, rental of cotton, popcorn and snow-cone machines, arrangement for ponies, clowns, and character shows, rental of chairs and tables". Furthermore, the cited mark is only for services in International Class 35.

Despite these vast differences, the Examiner appears to be making the argument that the cited mark may be used in connection with Applicant's goods. There is absolutely no proof of that. A search of the PTO's voluminous records revealed only nine registrations in International Class 35 for "inflatable rides", "cotton_candy machines", "popcorn machines", "snow-cone machines", "pony rides", "clowns", "character shows", "table rentals", or "chair rentals". See Exhibit 3. Given the number of above search

terms, this is a minuscule number of hits. Furthermore, the cited mark's website makes absolutely no mention of the provision of any of these services. See id.

Given the differences in services, namely, the cited mark's provision of simple party elements compared to the Applicant's provision of comprehensive entertainment services, it stands to reason that the services performed in connection with the Applicant's mark and the services offered in connection with the Applicant's mark are quite dissimilar and unlikely to be confused.

II. DISSIMILARITY OF CHANNELS OF TRADE.

Further, as to the cited mark, the Examiner may take note that the goods may be purchased at a store or via the internet. Conversely, Applicant's services can only be obtained through a series of negotiations concerning prices and rental arrangements. Given the very nature of services, namely, the sale of small-scale party supplies vs. the rental of large-scale entertainment units such as ponies or cotton candy machines, it is obvious that the transactions between the consumers and the suppliers would be vastly different.

Even if the products would appear in close proximity to each other,—"modern consumers would be less likely than their counterparts in previous decades to infer a connection between goods with the same mark, merely from the fact that they appear

together in a grocery store." Worthington Foods, Inc. v. Kellog
Co., 14 USPQ2d 1577, 1599 (S.D. Ohio 1990); see also, Interstate
Brands Corp., Inc., 198 USPQ at 153.

III. THE ABILITY TO EXCLUDE OTHERS FROM USING THE MARK.

Finally, the cited mark's presence on the Supplemental Register (see Exhibit 4), not the Principal Federal Register, is the single strongest piece of evidence in support of the narrowness of protection enjoyed by the prior mark. FTMEP \$205.01(a) provides that an Examiner may cite a mark on the Federal Trademark Register against a Florida trademark application. Given the reasons stated below, the cited mark should not be extended this protection.

As a leading treatise has eloquently summarized, it has been decided that "a Supplemental Registration confers no substantive trademark rights beyond those under common law." 3 McCarthy on Trademarks, \$19.36 (J. Thomas McCarthy 2005). Section 25 of the Lanham Act expressly excludes Supplemental Registrations from most of the advantages given to registrations on the Principal Register, including the inability to stop the importation of similarly marked goods from the U.S. and the fact that such a registration may not be used to provide prima facie evidence of the Supplemental Registrant's exclusive right to use of the mark. See id.

The Florida Trademark Act, which sets up a register which functions in a fashion similar to the Federal Principal Registry,



does not provide for the existence of a registry similar to the Supplemental Register. While descriptive marks may be eligible for the Supplemental Register, for example (see 4 McCarthy at \$19:42), in Florida the "registration of a mark that is 'merely descriptive' of the goods or services is prohibited." FTMEP \$204.02.

Given this, it follows that a mark must meet the same standards for registration on the Principal Register in order to be considered eligible for registration on the Florida Register. Not adhering to this principle could very well lead to the following result: A mark is found to be descriptive on the Florida registry and denied state registration. It then applies to be placed upon the Supplemental Registry, which allows descriptive marks. Once it is on the Supplemental Registry, Florida recognizes this mark as a valid mark, even though it is a descriptive mark that has already been rejected from the Florida Registry once and, barring a change to the governing statutes, never would have been allowed on the Florida Register. This disingenuous result should be avoided at all costs by refusing to extend the protections provided to marks on the Federal Principal Registry to marks placed on the Supplemental Registry.

Given that (a) the cited mark's presence on the Supplemental Register provides it with no protection other than those found under the common law, and (b) Florida has avoided creating its own version of the Supplemental Registry, \$205.01(a) of the FTMEP

should only apply to marks that are on the Principal Registry of the United States, not the Supplemental. As such, the cited mark should not be used against the Applicant's mark.

IV. STATUTORY AUTHORITY LACKING.

Although the Division of Corporations has always taken the position that it may reject a Florida Trademark application based upon a federal registration, there is no such statutory authority whatsoever. Fla. Stat. \$495.021. Specifically, \$495.021(f) permits, rejection only if there is a conflict with "a mark [previously] registered in this state..." (emphasis added). The statute is perfectly clear that a federal registration can only become relevant in a cancellation action brought by the owner of the federal registration. Fla. Stat. \$495.101.

With all due respect, the Examiner's citation is entirely misplaced. Nonetheless, even if it were a proper basis for a rejection under the statute, there is no likelihood of confusion as set forth above.

V. CONCLUSION.

For the above-stated reasons, Applicant submits that there is no possible likelihood of confusion or mistake on the part of prospective purchasers surrounding the use of Applicant's mark.

Having fully responded to the Examiner's action, Applicant

submits that this case is now in condition to be passed to registration and the same is respectfully solicited.






