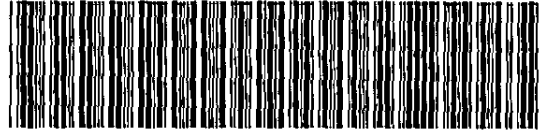

She is also surrounded by the graves of many the departed pets she gave service to during her life.
