

In response to your correspondence dated February 28, 2006, (copy enclosed) applicant hereby submits the amended application and following arguments in connection with the above-referenced service mark.

The Division of Corporations (hereinafter "Division") has refused registration of the applicant's mark based on the requirement of disclaimer. Specifically, the Division has required that the applicant disclaim the terms "MIAMI" and "ORCHID SHOW" apart from the mark as shown, because: 1) "All geographical terms, such as cities, states, countries, and designs of same, must be disclaimed," and 2) "Some commonly used words and corporate suffixes must also be disclaimed."

Applicant has now completed Part III of the Application to disclaim the exclusive right to use the term "ORCHID SHOW" apart from the mark as shown. However, as discussed in detail below, Applicant respectfully traverses the disclaimer requirement for "MIAMI" on the basis of distinctiveness under Section 307.03 of the Florida Manual of Trademark Examining Procedure (hereinafter "FTEP").

The Division has required disclaimer of the term "MIAMI" on the basis of geographical significance. See FTEP 108.09, FTEP 307.

While the Division allows for disclaimer of an unregistrable component of a mark otherwise registrable under FTEP 108.09, Applicant respectfully asserts that the term "MIAMI" in its mark is registrable on the basis of distinctiveness under Section 307.03 FTEP, and therefore the term should not be disclaimed.

Furthermore, under FTEP 307.03, "the Division may accept proof that the mark has become distinctive as applied to the applicant's goods or services and may thus be registrable. Like the United States Patent and Trademark Office, the Division is entitled to rely upon the applicant's sworn statement that the mark has been in substantially exclusive and continuous use for the five years next preceding the claim of distinctiveness. The applicant is not required to submit additional evidence of five years use."

Accordingly, applicant submits the attached declaration.

This response is submitted within sixty (60) days of the date of your action. Accordingly, applicant requests that its mark be accepted for registration.


