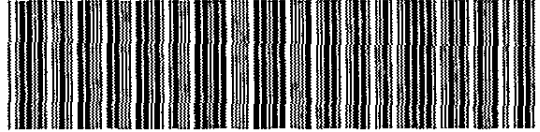

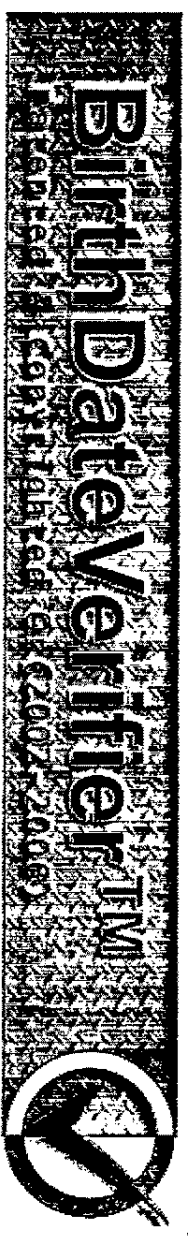

## Product Information

### Unique!

This product uses a unique combination of the Electronic Signatures in Global and National Commerce Act (E-Sign Act), 15 U.S.C. §7000, and the Unsworn Declarations Act, 28 U.S.C. §1745, which together allow for the submission of electronic documents under the penalties of perjury. These copyrighted statements, used in conjunction with a proprietary birth date verification script, amount to the equivalent of an 'electronic affidavit' stating the user's name and birth date. Moreover, the BirthDateVerifier™ Version 4.0 ("Verifier"), script records the user's IP address, along with the time and date of attempted access, thereby providing valuable support logs in the event proof of a user's identity is later required. All users are required to agree to the application of U.S. law to govern the transaction, thus making the device effective worldwide. The entire domain's inner pages are blocked by the Verifier unless the user enters through the birth date verification page. Therefore, all free tours or promotional content can be protected by a central access page. There is simply no comparison in the field of unpaid age verification.

Users are not required to provide personal information such as addresses, phone numbers, social security numbers or drivers' license information, as was found to be constitutionally problematic in
