This letter is in response to you letter dated December 26, 2006 (attached).

As per our telephone conversation on Wednesday January 3, 2007, please let this letter serve as my objection to the disapproval of my "MARK" as submitted. You informed me that the reason was other people where already using this name "HEIGHTS REALTY". However, they are not trademarked.

Recently I had a neighboring real estate agency (First Home Realty) incorporate the following names: 1) The Heights Realty & Mortgage, Inc. 2) Heights Realty Group, Inc. and 3) Heights Realty, Co.

Hence, the reason for my application of Trademark, to protect my name and therefore not create confusion for my customers past, present & future.

The fact that a person has incorporated a name doesn't give them any legal rights to that name (Florida Statue 607.0401 (5) - see page 3 - Item No. 1)

I have attached several additional samples on my "Mark", some of which date back to 1993. This should help approval of this application as submitted with regard to Florida Statue 495.021 (E) Paragraph no. 2. (see attachments).

Also, Florida Statue 495.021 (F) further states that a registration shall not be denied based on the registration of a corporate name or fictitious name by another party. (see page 3 Florida Statue 495.021 Registrability (F).

The State of Florida's, Trademark/Service Mark Registration Guidelines Item No. 1 - <u>states that marks are checked against other marks registered by the Division and not against corporations, fictitious names or other entities.</u>

I believe these Statues clearly support my position for Service Marking and furthermore as stated it will protect the public with regards to likelihood of confusion, mistake, or deception as defined in Florida Statue 495.011 DEFINITIONS (6b).

Also, with the additional samples of "HEIGHTS REALTY" mark usage that date back to 1993- this further provides proof of FIRST IN USE, FIRST IN RIGHT.
