ACCORDING TO JOHN

Building blocks of the Church are its young people

Dear Diocesan Family,

A major portion of this issue of the Central Florida Episcopalian is dedicated to an exploration of various aspects of our ministry to young people. I hope you will read it carefully, and that you will pray for these many ministries. Perhaps the Lord has a place for you to join us in this vital outreach.

Last year the Barna Group published the results of a study that

showed that "nearly half of all Americans who accept Jesus Christ as their Savior do so before reaching the age of 13... two out of three Christians made that commitment before their 18th birthday... and less than one out of four Christians embraced Christ after their 21st birthday." Teenagers and pre-teens are

the building blocks of the Church. It is as simple as that. And it has been so for a very long

time. But there is a new demographic reality that Canon Kevin Martin discusses in his current Newsletter. He writes, "It comes down to these two facts together:

Someone has wisely said that the Church of Jesus Christ is always only one generation away from extinction.

■ The GI

generation was over 60 percent churched.

■ The GI generation is dying at an average 1,000 a day. Despite an increasing longevity, they will soon no longer be with us in any large numbers.

They are being replaced by the millennial generation that is only 10 percent churched. To put it bluntly, do the math!"

Someone has wisely said that the Church of Jesus Christ is always only one generation away from extinction. If we fail to share the good news of Jesus Christ in



winsome, relevant, convincing ways with our young people; if we fail to bring them to mature, informed, and serious commitment to him; in short, if we fail to make disciples of our children and grandchildren we will have truly failed in one of our most important obligations.

The Psalmist wrote,

"God established a decree in Jacob, and appointed a law in

which he commanded our ancestors to teach to their children;

that the next generation might know them,

the children yet unborn,

and rise up and tell them to their chil-

so that they should set their hope in God.

and not forget the works of God, but keep his commandments; and that they should not be like their

a stubborn and rebellious generation. a generation whose heart was not stead-

whose spirit was not faithful to God." (Psalm 78:5-8)

One of the many things I find so exciting about the Diocese of Central Florida is the consistently high level of commitment to ministry to, among, and with young people in almost every one of our congregations. As we begin this new year, I ask that every one of us renew that commitment to do everything in our power to ensure that the young people entrusted to us don't miss out on the adventure of knowing and belonging to Jesus Christ and discovering what it is to have new life
