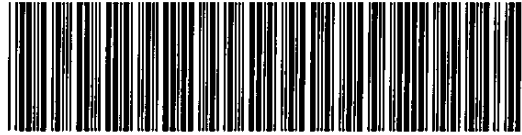

Dear Madam:

The three enclosed Applications for Registration are made by *Global Marine Travel LLC*.

These marks, but specifically in respect to the "Global Marine Travel" service mark, have been in use by the Applicant continuously since the first use, i.e. since December 2001, which is more than five years. This use has been substantial and exclusive. On the basis of this representation the Applicant qualifies for the "acquired distinctiveness" exception to the descriptiveness limitations of section 495.021.

We would also note that the services being sold are not *marine travel* but rather are air travel services marketed to personnel serving the *marine industry*, i.e., vessel officers and crew, and air travel for cruise passengers. Thus *marine travel* is not descriptive of the service to which the service mark attaches.

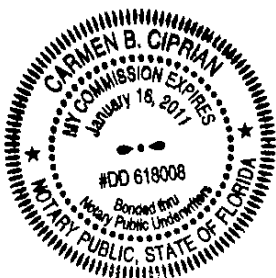
