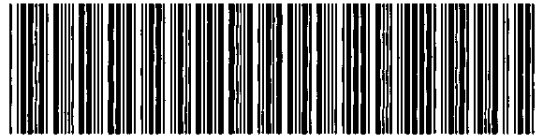

## Bill Moss. City Commissioner Comes to Board Meeting

At the Board Meeting on January 15<sup>th</sup>, Bill Moss, a City Commissioner, reassured residents of Trump that he was working in their interest. Our view will remain unchanged, if anything enhanced, as the only change on this section of Flagler will be plush landscaping - although there was mention of the possibility of a small Boardwalk along the present concrete walkway running along the water.



As that alarmed residents, Moss promised to look at the plans and return with more information.

He assured unit owners that the Library, Waterfront, two garages, and state of the art Photo Center, at a cost of \$5.3 million, will be financed entirely by the County which will contribute \$7.9 million to the city - a sum that

will increase over the next few years. The CRA (Community Redevelopment Agency) receives a portion of all taxes collected but does not levy taxes. It was created to address inner city blight. Along with the DDA (Downtown Development Agency), both are creatures of the state legislature. The latter created primarily to bring business to the downtown area. They run the trolleys, downtown security, landscape maintenance etc. Next year the DDA will halve their mill rate tax

Why a Photo Center? Statistics show - surprisingly - that the largest single tourist draw in Palm Beach County, is the Photo Center in Delray. World class photographers hold classes, explain techniques and host photographic exhibits. That single attraction brings in over \$70 million to the County.

Mr Moss thanked resident Bob Katzen for his efforts on behalf of Trump.
