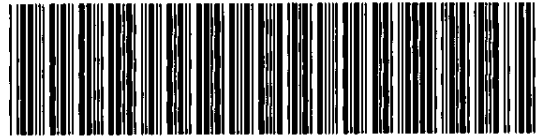

1. I am President of Baltimore Ravens Limited Partnership (RAVENS), a Maryland Limited Partnership located and doing business at 1 Winning Place, Owings Mills, MD 21117.

2. The RAVENS own and use in interstate commerce, including in the State of Florida, the RAVENS word mark.


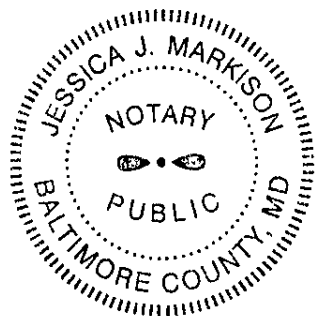
3. The RAVENS are exempt from the requirement that a business entity must obtain a Certificate of Authority to Transact Business from the Department of State in order to obtain a trademark registration in the State of Florida because the NFL qualifies under at least one of the exceptions to this rule as delineated in Florida Statute §607.1501(2).

4. The RAVENS, through NFL Properties LLC, is the exclusive representative for the licensing and protection of its names, logos, symbols and media, licenses independent contractors, i.e., sponsors and licensees, to produce and sell such products in the State of Florida. Thus, for trademark classes incorporating goods, the RAVENS are exempt from the need to obtain a Certificate of Authority pursuant to Florida Statute §607.1501(2)(e) which creates an exception for “[s]elling through independent contractors.”

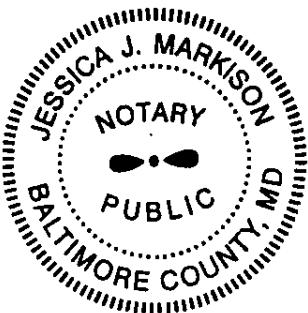
