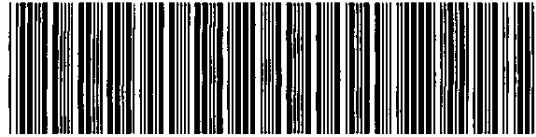

This is to confirm the action of the Commission for Independent Education at its meeting on September 16, 2009, regarding Kaplan College.

The Commission voted to grant a Provisional License for a period of one year.

Provisional Licensure indicates that the institution meets substantially all the standards for licensure. Under Provisional Licensure, the institution may advertise, recruit students, accept fees and tuition from or on behalf of students, and hold classes, but may not actually award a degree or a credential requiring one year or more to earn. Only any short-term credentials specifically approved by the Commission and appearing on the Approved Data sheet (enclosed) may be awarded during Provisional Licensure. No programs may be advertised or offered which do not appear on the Approved Data sheet.

The institution must attain an Annual License before awarding degrees or other credentials, or seeking the Commission's approval to add or substantially modify programs or to add locations. The institution may apply for Annual Licensure at any time that the remaining conditions and standards are met. If necessary, a Provisional License can be extended by the Commission under certain circumstances as outlined in Rule 6E-2.002(1)(d), Florida Administrative Code.

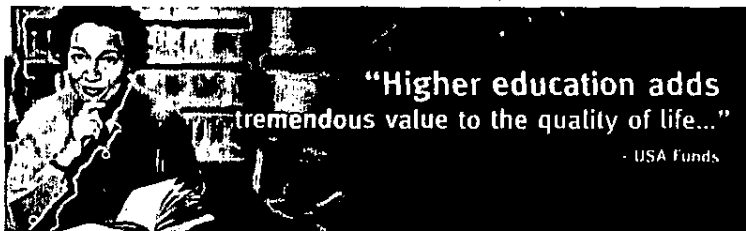
